Failure on the part of the pilot/operator to comply strictly with the requirements listed above shall automatically render any permission to land granted under this request to land null and void.</i></p>	

DISCLAIMER/WAIVER

I/We(name of operator/pilot and hereinafter referred to as the User) acknowledge that the landing strip at Kagga Kamma is unlicensed and that it is closed for all air traffic that has not been given written consent to land or take off by Kagga Kamma Ontwikkelings (Pty) Ltd (herein after “Kagga Kamma”).
The User may, entirely at its own risk, and subject to all the terms and conditions hereof, utilize the landing strip. The User hereby indemnifies and holds harmless Kagga Kamma , its Directors, employees, agents and / or shareholders, from all claims that the User or any of its passengers may have arising out of any injury (including injury resulting in death) or loss however caused (including gross negligence) sustained by them, arising from the use of the landing strip at Kagga Kamma.

KAGGA KAMMA PASSENGER WAIVER AND INDEMNITY

This indemnity must be signed by all persons entering the Reserve of 18 years and older.

I acknowledge that the landing strip at Kagga Kamma is unlicensed and that it is closed for all air traffic that has not been given written consent to land or take off by Kagga Kamma Ontwikkeling and that I / we are landing and taking off entirely at own risk.

I am aware that no representation is made about the serviceability of the airstrip or roads on the reserve.

I agree that Kagga Kamma Ontwikkeling, its Directors, employees, shareholders and / or affiliates shall not be liable for any damage to property, personal injury, death or other harm or loss of whatsoever nature, and howsoever caused, and whether arising from negligence or recklessness arising from the use of the landing strip at Kagga Kamma.

I indemnify and hold harmless the Kagga Kamma Ontwikkeling against any claim for loss or damage of any kind, including any dependent's claim, brought by any person arising from or in connection with any damage to property, or any harm or injury occurring on the reserve, whether or not arising from negligence or recklessness.

I undertake to bring the terms of this indemnity to the attention of any children in my care. I acknowledge that I sign this indemnity on behalf of such children and indemnify Kagga Kamma Ontwikkeling against any harm, loss or injury (including death) which may befall them while on the reserve, whether or not caused by negligence or recklessness on the part of Kagga Kamma Ontwikkelings.

I undertake to read the rules and regulations governing my conduct while on the Reserve and undertake to abide by them. I furthermore realise that I am entering a protected area and that all vehicles and aircraft are liable to be searched. Persons breaching the rules and regulations may be required by management to leave the Reserve immediately.

PROCEDURE AND FLIGHT RULES

Please submit your request to land to email: lodge@kaggakamma.co.za

Kagga Kamma Ontwikkelings will process your request, and in the event that permission is granted, will provide a written consent to land reference number.

No aircraft is allowed to land at the Kagga Kamma landing strip without consent and without submitting the signed disclaimers / waivers in respect of the pilot and all passengers on board.

The minimum height to be maintained over Kagga Kamma is 5500 feet above ground level. Aircraft should maintain height until close to the landing site or landing strip and then descend as per the required safety operating instructions of the aircraft. For departures, aircraft should ascend to the recommended height as soon as possible after take-off, as close to the take-off site as possible, before levelling off and entering a cruise.

All pilots must be aware of noise pollution and must minimize this problem as far as possible.

All aircraft must follow standard procedures for approaches and departures from the airstrip.

Aircraft may not be used for any form of game viewing.
